The bid documents for this Bid shall be amended, revised and changed in the following particulars:

Clarification:

1. "Grinder Pump", as furnished by the City, will include the grinder pump, basin and control panel.
2. The Awarded Vendor will furnish all other necessary materials, equipment and **services** to complete the installation, including electrical hookups.
3. Decommissioning of septic tank shall be the responsibility of the home owner, and the cost of such shall not be included in this quotation.
4. The scope of work for this RFQ provides for installation of only the primary residence grinder pump. All other equipment necessary for any other service to other structures on the property will be the responsibility of the home owner.
5. The type of grinder pump will be a cavity pump (examples: E-One, Myers, etc...), meeting all necessary requirements; provided by the City.
6. All installation associated landscaping shall be the responsibility of the home owner, and the cost of such shall not be included in this quotation.
7. Line installation shall be by open digging, or trenching. Other methods, such as, directional boring, shall be at home owners expense.
