The bid documents for this Bid shall be amended, revised and changed in the following particulars:

The following question was submitted by a potential bidder:

Question 1:

“I am a wholesaler, can you tell me how to base my price on retail pricing?”

Answer 1:

The following changes in the bid packet are necessary to facilitate bidding inclusive of wholesalers:

- a. Remove: ITEM III BID RESPONSE, page III-1
- b. Insert: ITEM III BID RESPONSE, (revision per addendum 3), see below
- c. On page V-1, Change from:

1. **DURATION**

- a. The term of the Agreement shall be for a period of one (1) year commencing on DATE OF CONTRACT SIGNING BY MAYOR, CITY OF FAIRHOPE, with the option to renew contract for up to Two (2) additional years if terms and conditions, including pricing, remain the same and both parties are in agreement to renewing the contract.

2. **PRICING**

- a. The Contractor will supply contracted items at _____% (percent) discount from retail price in effect the date the Purchase Order is issued.

c. (continued) Change to:

1. **DURATION**

- a. The term of the Agreement shall be for a period of six (6) months commencing on DATE OF CONTRACT SIGNING BY MAYOR, CITY OF FAIRHOPE, with the option to renew contract for up to thirty (30) additional months, in six (6) month increments, if terms and conditions, including pricing, remain the same and both parties are in agreement to renewing the contract.

2. **PRICING**

- a. The Contractor will supply contracted items at the quoted unit prices in the BID RESPONSE form.

Question 2:

“...are the 2000 calories based on 1 meal?”

Answer 2:

The 2000 calorie figure is a daily total recommended by the nutritionist. Each frozen meal should have a 650 calorie minimum.
